TESTIMONY LEAGUE OF WOMEN VOTERS OF TEXAS COMMITTEE ON JUDICIARY & CIVIL JURISPRUDENCE

I am Aimee Mobley Turney testifying as a member and on behalf of the League of Women Voters of Texas AGAINST HB 606. We appreciate the opportunity to appear before you today. Thank you for allowing us to share the League of Women Voters of Texas' position on this bill.

We oppose HB 606. Our position on gun safety, like other League positions, is derived through a lengthy and thoughtful process involving the participation of 25 local Leagues representing nearly 5,000 members and supporters throughout the state of Texas.

The League of Women Voters of Texas opposes this proposed legislation because it upends our established legal rules either to subject business owners to strict legal liability for choosing to prohibit handguns or to provide special legal protections to businesses that allow handguns on their property.

A business owner and/or its management has no way of knowing whether all persons concealing a handgun or openly carrying a handgun has a License to Carry or has had proper firearm training.

Approximately 1.7 million incidences of workplace violence occur annually in the U.S.ⁱ While the majority of incidents are considered "minor" assaults, an average of 564 workplace homicides occurred each year from 2004 to 2008.ⁱⁱ

In stark contrast to License to Carry applicant training, police officers receive hundreds of hours of training in marksmanship and non-violent conflict resolution, including role-playing real-life scenarios, to ensure that their firearms are carried safely and not fired carelessly.

HB 606 has the potential to increase incidences of workplace accidents, violence and homicides by giving business owners no choice but to allow handguns on their property.
